With the present letter, EVAC GmbH (hereinafter referred to as "EVAC"), located at the address Feldstraße 124, 22880 Wedel, Germany, informs BRANCH "PASSENGER COMPANY" OF JOINT STOCK COMPANY "UKRAINIAN RAILWAY" about EVAC's attention to purchase procedure UA-2021-06-25-007765-c, holding by BRANCH "PASSENGER COMPANY" OF JOINT STOCK COMPANY "UKRAINIAN RAILWAY" for purchasing spare parts for vacuum toilets produced by EVAC.

EVAC was informed that the PASPORT OF THE SPAREPARTS DELIVERY dated 01.07.2021 has also been provided by the following companies: LLC "EURO TEK" (TOB "CBPO TEK", registration number 43052413) and LLC "ATOR CONSULTING" (TOB "ATOP KOHCAJTИHГ", registration number 41432261) in the tender procedure UA-2021-06-25-007765-c. EVAC did not provide or sign this document to these companies.

In addition, we would like to point out that the passport is made on old blank of EVAC. The letterhead was changed in June 2021 to Knorr-Bremse EVAC. Please visit our website www.evac-train.com for approval. Also, we can confirm that Stefan Klingler is not working at EVAC since the beginning of 2021. Therefore it was not possible for Stefan Klingler to sign this document on 01.07.2021.

Furthermore EVAC would also like to inform BRANCH "PASSENGER COMPANY" OF JOINT STOCK COMPANY "UKRAINIAN RAILWAY" that authorization letter from August 10, 2020 for OOO PILLOR-Evac, Russia does not cover the Ukrainian market. Therefore OOO Pillor-EVAC is not authorized to sell EVAC products in the territory of Ukraine.

We kindly ask you to take this information into account for the tender procedure UA-2021-06-25-007765-c.
